★ Message from IDVA Director Terry Prince



As we close the summer, I thank my dedicated team who has given its all in meeting with veterans across our state at resource, county, and state fairs, picnics, parades, ceremonies, and programs. They have given up summer evenings and weekends with friends and family to inform veterans of their earned benefits and the services IDVA provides. We are fortunate to live in a state where the Administration is dedicated to seeking avenues in veterans' best interests. Recently, Governor JB Pritzker signed a law protecting veterans from "claims sharks," people and services that charge veterans

for assisting with claims. IDVA, county, and federal Veteran Service Officers provide counsel and claims assistance at no cost to veterans. Be aware of "claims sharks" who are taking advantage of veterans. IDVA recently learned of a veteran who paid a service \$100,000 of his \$300,000 claim. Unconscionable. Read on to learn more about this law and its veterans' protections and be on the lookout for scams!

September is National Suicide Prevention Awareness Month, an issue that is extremely important to me. I've shared this message many times, that we must continue our crusade to prevent veteran suicide until the staggering number of 22 veterans taking their lives daily is reduced to zero. Veteran Consumer Protection Legislation Becomes Law

Governor J.B. Pritzker signed SB 3479, now Public Act 103-0783, which protects veterans from “claim sharks,” who charge fees for assisting a veteran in obtaining their earned benefits and services, while these services are provided at no cost by county, state, and federal governments.

“IDVA has heard unimaginable stories from veterans who have lost thousands of dollars of their earned benefits to services taking advantage of them, often at their most vulnerable,” said IDVA Director Terry Prince. “We are grateful to the bill’s sponsors Senator Mike Porfirio & Representative Stephanie Kifowit, and Governor Pritzker for advocating for veterans by securing these important protections. We encourage veterans to contact IDVA Veterans Service Officers positioned around the state and equipped to help them navigate their benefits and services, free of charge.”

This effort started over two years ago with [Public Act 102-0386](#). Public Act 102-0386, effective January 1, 2022, amended the Consumer Fraud and Deceptive Business Practices Act. It defined “veteran or military benefits services” and provided that a person or company advertising veterans’ benefits services must conspicuously disclose that such services are offered free of charge from county veterans service officers, the Illinois Department of Veterans Affairs, and federally chartered veterans’ service organizations.

SB 3479, now [Public Act 103-0783](#), amends the same Act. It builds upon existing law in the following ways:

- It expands the definition of “veteran or military benefits services.” The new law adds language to provide that “consulting or coaching in the preparation, presentation or prosecution of claims” is considered a service.
- It requires additional language for veteran services disclosures.
- It provides that failure to provide a veterans’ services disclosure orally and in writing at the outset of the business relationship is an unlawful practice.
- It specifies that Veteran Service Officers be accredited by the VA.

Overall, it ensures there are no loopholes for “claim sharks.” The law is effective January 1, 2025.

GI Bill® Turns 80

Throughout the year, the nation recognizes the 80th anniversary of the GI Bill which has changed the trajectory of hundreds of thousands of veterans since its inception. While World War II continued, the Servicemen's Readjustment Act, known as the G.I. Bill, was debated in Congress and signed into law on June 22, 1944. The intent was to provide veterans of World War II essential benefits including hospitals, low-interest mortgages, and mostly stipends to cover higher education and vocational schools. Since then, hundreds of thousands of veterans have pursued higher education through the GI Bill leading to successful and meaningful careers.

In 1984, legislation was enacted to provide Vietnam War veterans higher education benefits, and in 2008, the Post 9/11 Veterans Educational Assistance Act gave veterans on active duty on September 11, 2001, benefits including allowing the transfer of unused educational benefits to their spouses and children. In 2012, the U.S. Department of Veterans Affairs (VA) trademarked the GI Bill to prevent unauthorized educational institutions or vendors from misusing the term. In 2017, the Veterans Educational Assistance Act called the Forever GI Bill became law and expanded GI Bill benefits for eligible veterans and their dependents.

For over a decade, Illinois has been a nationwide leader in applying the GI Bill for apprenticeship and on-the-job training programs, with over 625 such facilities approved and averaging over 1,500 monthly trainees.

In 2023, Illinois averaged 12,500 students or trainees using GI Bill benefits per month. During federal fiscal year 2023, Illinois GI Bill beneficiaries brought in approximately \$220 million in benefits. Over the past 10 years, Illinois has seen \$2.495 billion in GI Bill benefits, averaging under \$250 million annually.

The Illinois State Approving Agency currently has 1,361 programs of education and training facilities approved for GI Bill benefits with 825 of those facilities having at least one active veteran in training or pursuing an education during 2023.

NATIONAL AGENT ORANGE AWARENESS DAY

Agent Orange Awareness

During the Vietnam War, the U.S. military sprayed a mix of tactical herbicides called Agent Orange to remove dense tropical foliage from trees and plants to reduce enemy cover. The USDVA recognizes that exposure to Agent Orange has resulted in a wide range of diseases and health conditions including leukemia, heart disease, Parkinson's, prostate cancer, diabetes, and more. Eligible veterans who have been exposed can receive health care benefits and an Agent Orange Health exam. Veterans may also be eligible for disability compensation if they have a disability related to Agent Orange exposure and were then discharged.

On February 6, 1991, the Agent Orange Act of 1991 was established. It presumes that any veteran who served during the Vietnam War has been exposed to tactical herbicides. The USDVA offers a variety of resources and compensation for veterans who have been affected by Agent Orange and other herbicides during military service.

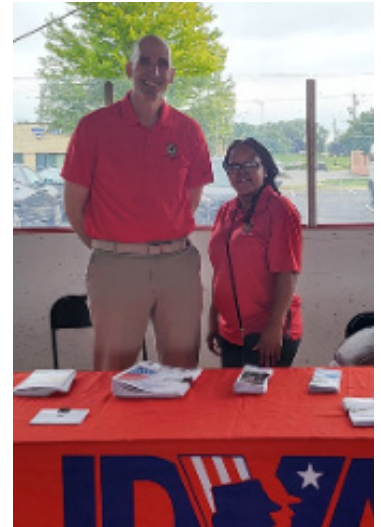
