News from the Capitol

In July, the United States Department of Veterans Affairs (USDVA) announced funding shortfalls for the Veterans Health Administration (VHA) and the Veterans Benefits Administration (VBA) beginning October 1st and totaling \$15B. To ensure monthly benefits were paid on time, Congress [passed an emergency spending bill](#) to address the 2024 VBA shortfall.

The [PACT \(Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxins\) Act of 2022](#) was signed into law in August 2022. Since that time, over 700,000 veterans have enrolled in VA health care. Serving current and new enrollees is essential, and USDVA believes the shortfall is due to:

- Need for additional staff
- Increased costs for Community Care
- Increased costs for drugs and prosthetic devices

Congress and the USDVA are creating long-term strategies to ensure that the USDVA has the funding it needs to provide veterans with their earned benefits.

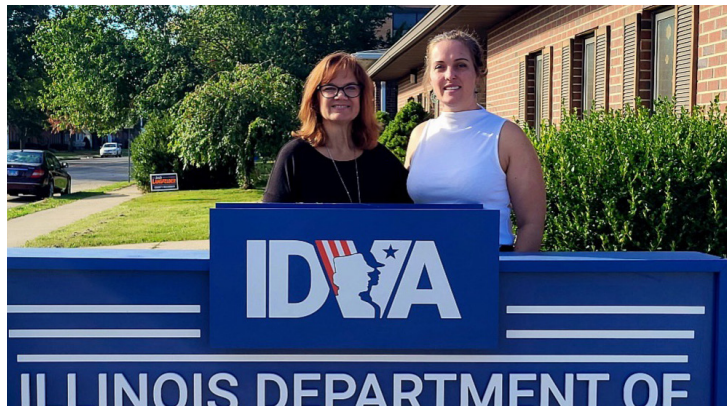
